I. Call to Order

The Committee's Chair, Mr. Stephen Mason, called the meeting to order at 2:00 p.m.

II. Roll Call

The Board's Secretary, Mr. Zach Atwell, called roll:

Dr. Clara Ross Stamps, Senior VP for Brand Identity and University Relations, Regent Hatchett, and Mr. Michael DeCourcy, Executive Director of Institutional Advancement, also were present. Regent Walston, Regent Briggs and Mr. Graves joined the meeting shortly after roll-call.

III. Approval of the Agenda

MOTION by Dr. Wang:

Move the Committee to approve the Agenda of the March 31, 2023, Weekly meeting of the Presidential Search Committee.

Seconded by Mayor Wilkerson and passed without dissent.

IV. Committee Update

Chair Mason presented all Agenda Information Items, below, and stated that almost of all of the public forum dates have been set.

A. Faculty/Staff Public Forum (March 31, 2023)

Chair Mason remarked that the faculty/staff forum was held this morning and the recording is available.

B. Community Public Forum (April 5, 2023)

Chair Mason stated that this will be held in the Frankfort City Hall at 5:00 p.m. on Wednesday, April 5, 2023.

C. Tentative Student Forum

Next, Chair Mason commented that the date and time for the student forum has not yet been determined, though it is anticipated to be held during the week after next.

D. Tentative Alumni Forum

Chair Mason reported that the Alumni Forum will be held via Zoom on Tuesday, April 4, 2023, at 5:00 p.m.

V. Information Item

A. Myers McRae Executive Search Firm

Chair Mason introduced Mr. Kenny Daugherty, President of the Myers McRae executive search firm, and asked him to present this Agenda item.

Mr. Daugherty provided an overview and update as to the search process and the candidates that they were seeing, then presented the executive search status report as of March 31, 2023.

Regent Walston asked Mr. Daugherty if he could provide a copy of the status report to committee members.

Mr. Daugherty stressed the importance of committee members maintaining confidentiality throughout the process, and described the process by which they could access and review resumes in the portal.

Dr. Mayberry requested Mr. Daugherty to clarify what types of information would be appropriate to include in the comment boxes.

Chair Mason asked how long it typically takes to go through an application and fill out the evaluation form, and further queried whether it was possible for committee members to view their comments anywhere at any time so they can be reviewed during the closed session discussions of candidates.

Chair Mason requested clarification that committee members would have access to all applicants' information, (not just the candidates pre-screened by the search firm) and also asked when the portal will open.

Regent Walston asked whether the search firm would have vetted the candidates in any way prior to sending them to the search committee in order to highlight anything that the committee might need to know about those individuals.

Dr. Wang inquired what reasons might preclude the search firm from moving a candidate onto the PR list within the portal, and clarified that the committee would still be able to review all candidate applications, whether or not they were on the PR list.

Regent Walston asked what the firm does with the written references and representations provided by each candidate, and whether they would be vetted and verified. Regent Walston also inquired whether candidates' claims regarding research would be verified.

Chair Mason asked if any of the five semi-finalists or three finalists had significant research publications or papers in their background, and their research is what puts them on the PR list, would the search firm then be able to "research their research".

Mr. Daugherty also introduced his team, and provided an additional timeline for various steps and stages within the search process.

Dr. Wang queried, in the event that a large number of resumes were received near the application deadline, whether there was a concern that the Committee may not have as much time to spend on those applications prior to meeting with Mr. Daugherty to select candidates for Zoom interviews.

VI. Old Business

Chair Mason stated that there was no old business.

VII New Business

Chair Mason stated that there was no new business.

VIII. Next Meeting Date

Chair Mason asked when the Committee would prefer to meet next week, noting that next Friday is Good Friday.

Regent Walston asked at what time would the Committee meet if they met next Thursday instead of Friday, and how long that meeting would likely last.

Chair Mason remarked that if the group met Thursday, it would be a special call meeting and no deviation from the Agenda would be allowed.
