Course one:  $17 \times 20 = 340$ Course two:  $11 \times 15 = 165$ Course three:  $10 \times 15 = 150$ Course four:  $16 \times 5 = 80$ Course five:  $14 \times 10 = 140$ Calculation Total for Part 6.a. = 875
